Current Financial Stability: City Council District 14 residents were most likely to say that wages (51% of all City Council District 14 respondents), housing (43.7% of all City Council District 14 respondents), and stable hours at work (36.2% of all City Council District 14 respondents) keep them financially stable.

Current Financial Needs: City Council District 14 residents were most likely to say that higher wages (68.2% of all City Council District 14 respondents), more affordable housing (66.8% of all City Council District 14 respondents), and better health/healthcare (39.4% of all City Council District 14 respondents) were needed to feel economically secure.

Biggest Impacts from COVID-19: City Council District 14 residents were most likely to say that lower/lost wages (49.3% of all City Council District 14 respondents), lost or insecure employment (40.2% of all City Council District 14 respondents), and impacted health/healthcare (33.5% of all City Council District 14 respondents) were the biggest impacts from COVID-19.

Current Financial Stability: City Council District 15 residents were most likely to say that wages (44.8% of all City Council District 15 respondents), stable hours at work (33.2% of all City Council District 15 respondents), and housing (30.2% of all City Council District 15 respondents) keep them financially stable.

Current Financial Needs: City Council District 15 residents were most likely to say that higher wages (71.6% of all City Council District 15 respondents), more affordable housing (60.8% of all City Council District 15 respondents), and better health/healthcare (34.1% of all City Council District 15 respondents) were needed to feel economically secure.

Biggest Impacts from COVID-19: City Council District 15 residents were most likely to say that lower/lost wages (53.4% of all City Council District 15 respondents), lost or insecure employment (40.5% of all City Council District 15 respondents), and impacted health/healthcare (37.1% of all City Council District 15 respondents) were the biggest impacts from COVID-19.
